

“APP 10%” General Promotional Terms and Conditions
(hereinafter referred to as the: **“General Promotional Terms and Conditions”**)

I. Preliminary provisions

1. These General Promotional Terms and Conditions entitled: **“APP 10%”** hereby stipulate the rules of functioning, terms and conditions as well as the scope and complaint procedure of the Promotional Offer, terms of use as well as the rights exercised by the persons participating in the Promotional Offer, as well as the obligations on the part of the Organizer.

2. The Organizer of **“APP 10%”** Promotional Offer is eobuwie.pl Spółka Akcyjna (a joint-stock company) having its registered seat in Zielona Góra, 9 Nowa Street – Nowy Kisielin, 66-002 Zielona Góra, entered into the business register of the National Court Register kept by the 3. District Court in Zielona Góra, VIII Economic Division of the National Court Register, under the entry number: 0000541722, NIP (state tax identification number): 9291353356, REGON (statistical office number): 970569861, share capital: 2,000,000.00 PLN fully paid up (hereinafter referred to as the **„Organizer”**).

3. The promotion is conducted in the Organizer's online store available at www.efootwear.eu ("Online Store"). The Promotion may be attended by Customers who, after fulfilling the conditions of participation in the Promotion, become participants in the Promotion (hereinafter also: **"Participant of the Promotion"**).

II. The Subject Matter of the Promotional Offer and its terms of use

1. The subject of the Promotion is the possibility for the Promotion Participant to use the Promotion on the terms specified in the Promotion Terms, including the granting of a discount to the Promotion Participant during the Promotion, which reduces the Price of the Products indicated in the efootwear.eu mobile application (hereinafter also: "Subject of Promotion").

2. The promotion stays valid from **21.10.2020 at 00:01 to 31.12.2021 at 23:59** (hereinafter referred to as the **„Promotional Period”**)

3. The participation in the Promotional Offer is voluntary and free of charge (that is any purchase of Products within the Promotional Offer does not require incurring by the Participant of the Promotional Offer additional costs except for paying the Price of Products subject to the Promotional Offer as well as the costs selected by the Customer, including delivery costs).

4. Some of the products may be excluded from the Promotion during the Promotional Period.

5. In order to take part in the Promotional Offer one should within the Promotional Period:

- a) familiarize oneself with these General Promotional Terms and Conditions and accept them;
- b) add Promotional Products to the Shopping Cart;
- c) before placing the order - in the Cart section - enter the discount code: **APP10** and press the "Apply Coupon" button. Submission by the Participant of the Promotion of the above discount code after placing the Order does not entitle you to take advantage of the Promotion. If the code is not typed in, it means that the buyer has waived the right to use the Promotion in relation to the given transaction. In such a situation, at the moment of making the payment, he ultimately loses the right to use the Promotion in relation to the transaction made.

6. As part of the Promotion, the regular Price for the Product or Products purchased by the Promotion Participant in the mobile application of the efootwear.eu Online Store will be reduced by 10% for purchases for a minimum of EUR 50 for non-discounted products.

7. The promotion does not include (does not reduce) any delivery costs of the Products purchased as part of the Promotion, which the Promotion Participant incurs in the full amount. Some products may be excluded from the Promotion during its duration.

8. The promotion is not combined with other promotions, discounts, rebates, reductions, promotional

campaigns, special price or product offers that are valid in the Online Store, unless the terms of such promotion, discount, rebate, promotion, special price or product offer constitute otherwise.

9. In the case of simultaneous purchase of several Products covered by the Promotion, the discount is calculated for each of the Products separately.

10. The subject of the Promotion is not subject to payment in cash or exchange for any other means of payment and is non-transferable.

11. The promotion does not include:

- a) Discounted products (i.e. Products whose Price has already been lowered before the Promotion, including Products located in the tab <https://www.e footwear .eu/filter:sale.html>); and
- b) Brand products excluded from the Promotion, the list of which is available in the https://e footwear .eu/brands_excluded_from_the_special_offer tab; and
- c) Products whose Price has already been covered by vouchers, vouchers, promotions, discounts, rebates or other special price or product offers.

III. Complaints

1. Any complaints pertinent to the Promotional Offer can be submitted by the Participants of the Promotional Offer in particular electronically at the following email address: info@e footwear .eu or by post at the following Organizer's address: eobuwie.pl S.A., 9 Nowa Street – Nowy Kisielin, 66-002 Zielona Góra (hereinafter referred to as the "**Complaints**").

2. With a view to accelerating the Complaint-adjustment process we kindly request providing the name and surname of the Participant of the Promotional Offer, contact details (for example, an email address or telephone number) as well as specifying the reasons substantiating the Complaint.

3. Expressing an opinion about the Complaint by the Organizer shall take place immediately, no later than within 14 days from the day of submitting it.

4. Complaints shall be considered by the Organizer, applying in particular the provisions of these General Promotional Terms and Conditions.

IV. Final provisions

2. Unless it is clear from the context that nothing else is used in the Promotion Terms, capitalized returns have the meanings assigned to them in the Online Store regulations available at: <https://www.e footwear .eu/regulations>.

3. The organizer reserves the right to change the Promotion Terms in the event of an important reason understood as (closed catalog):

- a. change of law regulations regulating the terms, rules and organization of the Promotion, affecting the mutual rights and obligations of the Organizer and the Promotion Participants;
- b. change in the method of conducting the Promotion due to technical or technological reasons;
- c. change in the way of providing services solely due to technical or technological reasons
- d. changing the scope or provision of services to which the provisions of the Regulations apply, by introducing new, modification or withdrawal by the Seller of the existing functionalities or services covered by the Regulations.

4. In the event of a change in the Promotion Terms, the Organizer shall provide the consolidated text of the Promotion Terms by publishing it at <https://www.e footwear .eu/app10regulations>

5. Changes to the Promotion Terms and Conditions are valid from the moment they are clearly identified and placed at the address indicated above.
